# ESF - making a difference

As we start a new year, we are featuring a couple of projects already delivering some life changing results...

#### Single Parent Employment Pathway project

Gingerbread (a well-known charity for single parent families) runs the **Single Parent Employment Pathway** project which helps single parents into employment, education, training and job search in the Liverpool City Region. Participants are able to take advantage of a range of opportunities which include:

- volunteering with partner organisations;
- employment coaching sessions including CV writing and interview skills;
- linking participants with appropriate educational support.

As at January 2018 97 single parents had entered work and 59 were entering further training or job search activities. The project has been supporting over 450 single parents.

#### Food for Change

Food for Change is led by the Cornwall Food Foundation with local partners, and has built four local food partnerships in Redruth, Truro, St Austell and Newquay enabling people who use foodbanks, mental health services and community centres to address barriers to their active inclusion in the economy. The project will facilitate individual progression using four key areas that provide **work experience**, **personal support** and **food-based training**, including, where appropriate, accredited qualifications.

- Think food: informing people about nutrition and food budgeting.
- Grow food: teaching skills from soil preparation to planting and harvesting.
- Cook food: promoting healthy, budget-conscious cooking.
- **Trade food**: giving practical experience in food businesses, foodbanks and community gardens.

#### Skills Support for Redundancy project – New Anglia LEP area

Run by TCHC (The Consultancy Home Counties) and co-financed by the Education and Skills Funding Agency, this project is working with over 200 employees facing redundancy, or having been made redundant in the last 6 months, helping them to stay in the labour market by enhancing their skills. The service works in conjunction with Jobcentre Plus, employment agencies and other local partners. The project:

- responds quickly to employer's needs by offering their staff targeted information advice and guidance.
- focuses on training opportunities to up-skill or re-skill employees, helping to retain skilled workers in the local area and key sectors.
- provides employment and careers coaching, mentoring, job brokerage, training and reskilling.

By January 2018 of those people that have been made redundant around 50 have already found paid employment and apprenticeships.

# Applying for ESF and other ESIF funds – to Note

ESF, European Regional Development Fund and European Agricultural Fund for Rural Development Calls for Applications are published on the GOV.UK website European Structural and Investment Funds (ESIF) 'funding finder'.

To respond to a call, applicants need to access the ESIF funding finder tool and adhere to the call document instructions/guidance. Supporting information on the Structural Funds can be found via the GOV.UK <u>England European Structural and Investment Funds guidance page</u>.

We have recently discovered that a few (ESIF) partner websites are encouraging ERDF and ESF applicants to apply for funding using the Logasnet system, which was introduced around 2 years ago and was only in operation for around 3 months. If your website, partner sites or documents still point potential applicants to this system could you please remove the reference.
