#### **STATEMENT OF POLICY**

- ANWC is committed to reduce the negative impact of its business on the environment and play its part in preventing pollution. Career Connect will comply with relevant environmental legislation and best practice guidelines and set objectives & targets to drive continuous improvement.
- ANWC will measure and control elements of SD within ANWC HQ building. All other ANWC staff members are co-located in other locations (including custody and community sites), therefore they have no control over lowering energy costs, water etc. We will however ensure all ANWC

staff are aware of SD and the importance to ANWC as an organisation. ANWC staff will evidence a commitment to adhere to SD principles (low carbon travel etc.) where possible.

• ANWC will report their progress against the implementation plan on a six monthly basis to ensure all aspects receive full coverage and remain high on ANWC's agenda.

#### **SUB-CONTRACTORS**

When AWNC uses subcontractors we will check to ensure they have a SD policy and implementation plan and that their environmental and sustainability practices comply with all SD principles.

#### RESPONSIBILITY

The Project Manager will ensure this policy is carried out across the project

The ICT Manager is responsible for developing and monitoring the implementation of aspects of this policy which relate to computers and other technical equipment.

The Assistant Director of Finance is responsible for overseeing environmental issues relating to premises, waste reduction, car usage and procurement.

The Human Resources Manager will support the promotion of environmental awareness amongst staff and manage initiatives relating to reducing car usage as part of the staff welfare & benefits policy.

The Marketing & Communication Manager is responsible for monitoring environmental performance, reviewing & communicating the policy and related documents & promoting environmental awareness.

Designated members of the IT Team are responsible for supporting the monitoring & reporting of environmental performance and adherence to contractual requirements such as the safe disposal of electrical and electronic equipment.

All staff have a responsibility for environmental protection when carrying out their duties, in association with service users and partners
